ELIGIBILITY: Open to all artists 18 years and older. All Work **Must Be For Sale**. This is a judged exhibition.

All work, wall-hung or 3 dimensional, must be safe, ready to display, framed and **wired** appropriately for hanging. Serrated hangers will **not** be accepted. Please notify us if you have a piece that needs to be displayed in an unusual fashion or if you have an unusually large piece over 36" to verify sufficient space is available. All work **must be original**, less than 3 years old and not previously exhibited in the Pekin Days Art Show. No more than three (3) entries may be submitted.

NCAC reserves the right to reject any entry that does not meet eligibility requirements. Entry to this show implies agreement to these conditions and those explained within this brochure. Entry fee is non-refundable.

A **25%** commission will be retained by NCAC on all sales. All sales will be made to the NCAC plus the state sales tax. The artist will receive a check for the amount of the stated purchase price less commission within two (2) weeks after the closing of the show plus applicable cash awards.

****Choose your division and category for each entry**

- I Paintings – Categories: Oil, Watercolor, Acrylic, Pastels, Other
- II Drawings – Categories: Pencil/Colored Pencil, Pen and Ink, Charcoal, Other
- III Pottery/Glass (If number of entries allow, this will be separated)
- IV Sculpture
- V Photography – Black/White and Color or Digitally enhanced
- VI Mixed Medium
- VII Textile
- VIII Traditional
- IX Diversified
- X Jewelry – All forms
- XI Printmaking – All forms

Please Read Carefully to Determine which division and category your entries fall under.

If artist feels it falls into a specific category that is not listed please explain on entry.

Paintings, Drawings, Pottery/Glassware - should be self explanatory.

Sculpture - any 3-Dimensional work regardless of medium.

Photography - black/white and color or all hand colored or digitally manipulated.

Mixed Medium - the use of two or more mediums - if there is a predominant medium used consider placing it in that division/category.

Traditional Art - any work based on an individual culture or created in a folkart style. e.g. beading, Native flute making, pysanka, Scandinavian rosemailing, mosaics.

Diversified - work that does not fall under specific divisions or categories.

Jewelry - All forms

Printmaking - All forms

Remember: ALL WORKS MUST BE ORIGINAL by you and not factory made!

Some artwork may fit more than one division/category. The artist must place the work in his/her chosen division/category. **Your noted division/category may be changed if judge feels it's better suited for another division/category.**
